CLARIFICATION TEXT ON THE PROTECTION AND PROCESSING OF PERSONAL DATA

("Clarification Text")

1. General Description

Within the scope of the law, personal data includes all kinds of data relating to an identified or identifiable natural person. Sensitive Personal Data, which is a special type of personal data, refers to race, ethnicity, political opinion, philosophical belief, religion, sect, other beliefs, disguise and dress, membership to associations, foundations or unions, health, sexual life, criminal convictions and security measures, biometric and genetic data.

Processing of personal data refers to all kinds of operations performed on personal data such as obtaining, recording, storing, preserving, changing, rearranging, disclosing, transferring, taking over, making available, classifying or preventing the use of personal data by fully or partially automatic or non-automatic means, provided that it is a part of any data recording system.

2. Data Controller

Your personal data may be processed by BMS GERI DÖNÜŞÜM SANAYİ VE TİCARET ANONİM ŞİRKETİ ("Data Controller") in the capacity of data controller, in accordance with the Law on the Protection of Personal Data No. 6698 ("Law") within the scope described below.

3. Collection of Personal Data, Legal Reason and Purposes of Processing

Although your personal data may vary depending on the service provided by the Data Controller and the commercial activities of the Data Controller, in accordance with the Law; It can be collected by automatic or non-automatic means, verbally, in writing or electronically.

Your collected personal data, in accordance with the basic principles stipulated in the Law and within the personal data processing conditions (legal reasons) specified in Articles 5 and 6 of the Law and shown below; It can be processed by BMS GERI DÖNÜŞÜM SANAYİ VE TİCARET ANONİM ŞİRKETİ for the following purposes. 5. As a personal data owner, you are subject to Article 11 of the Law. Your Rights Listed in the Article

Pursuant to Article 11 of the Law, we inform you that you, as data subjects, have the following rights:

- To learn whether your personal data is processed or not,
- If your personal data has been processed, requesting information about it,
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom your personal data is transferred at home or abroad.
- Requesting correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to third parties to whom your personal data has been transferred,
- Although it has been processed in accordance with the Law and other relevant provisions of the law, to request the deletion or destruction of personal data in the event that the reasons requiring its processing disappear, and to request the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- Objecting to this in the event that a result arises against you by analyzing the processed data exclusively through automated systems,
- Requesting compensation of the damage in case you suffer damage due to unlawful processing of your personal data.

If you submit your requests regarding your rights to us through the methods stated below, the request will be concluded free of charge as soon as possible and within thirty days at the latest, depending on its nature.

In order to exercise your rights, after filling and signing the relevant person/data owner application/request form, a copy of which is available at www.bmsgeridonusum.com.tr or you can get physically from the Data Controller, this application form or your originally signed petition to use your rights;
